Summary The NSW Health Services Aboriginal Cultural Engagement Self-Assessment Tool (the engagement tool) aims to identify ways of strengthening cultural engagement between NSW Health organisation staff and their Aboriginal stakeholders by bringing a continuous quality improvement cycle to cultural engagement. The engagement tool will support health services to assess whether there has been a measured approach towards the delivery of culturally safe and accessible health services for Aboriginal patients and clients.

# NSW HEALTH SERVICES ABORIGINAL CULTURAL ENGAGEMENT SELF-ASSESSMENT TOOL

#### **GUIDELINE SUMMARY**

The NSW Health Services Aboriginal Cultural Engagement Self-Assessment Tool (<a href="https://www.health.nsw.gov.au/aboriginal/Pages/cultural-engagement-tool.aspx">https://www.health.nsw.gov.au/aboriginal/Pages/cultural-engagement-tool.aspx</a>) aims to identify ways of strengthening cultural engagement between NSW Health organisation staff and their Aboriginal stakeholders by bringing a continuous quality improvement cycle to cultural engagement.

It has been designed to assist NSW Health organisations in moving towards a health system where cultural differences and strengths are recognised and responded to in the governance, management and delivery of health services. It supports health services to assess whether there has been a measured approach towards the delivery of culturally safe and accessible health services for Aboriginal patients and clients.

The Engagement Self-Assessment Tool identifies actions to strengthen Aboriginal cultural engagement between NSW Health organisations/services and local Aboriginal stakeholders. Importantly, it provides evidence during the accreditation process against the Aboriginal specific actions in the National Safety and Quality Health Service Standards and the strategic directions of the *NSW Aboriginal Health Plan 2013-23*.

## **KEY PRINCIPLES**

The NSW Health Services Aboriginal Cultural Engagement Self-Assessment Tool is underpinned by the seven principles of the NSW Aboriginal Health Plan 2013 – 2023. These principles are:

- Trust and cultural respect
- Recognition of the cultural values and traditions of Aboriginal communities
- Holistic approaches to the health of Aboriginal people
- The valuable and unique role of Aboriginal Community Controlled Health Services (ACCHS's)
- The participation of Aboriginal people at all levels of health service delivery and management
- Partnership with Aboriginal communities through ACCHS's and the Aboriginal Health and Medical Research Council of NSW.
- Recognition of the contribution the health system can make to the social determinants of health

#### **USE OF THE GUIDELINE**

The NSW Health Services Aboriginal Cultural Engagement Self-Assessment Tool is available on the NSW Health website as an interactive PDF for use in local health districts (LHDs), specialty health networks (SHNs), as well as facilities and services



including but not limited to individual hospitals, community health services and specialty services.

The interactive PDF uses a traffic light system for all users to record their progress toward cultural engagement and to develop an action plan to improve engagement with their local Aboriginal stakeholders. Areas requiring more work may be recorded within the PDF to review and monitor progress as determined locally.

The NSW Health Services Aboriginal Cultural Engagement Self-Assessment Tool has also been uploaded to the Quality Audit Reporting System (QARS) by the Clinical Excellence Commission to facilitate consistent assessment of cultural engagement across LHDs and SHNs and to support accreditation for all major hospitals. To support Accreditation, it is recommended that the Self-Assessment Tool is completed for individual facilities across the organisation under the direction of Directors of Clinical Governance.

The Centre for Aboriginal Health will request reports annually from the Quality Audit Reporting System from all LHD/SHN Chief Executives to inform monitoring of cultural engagement. Annual action plans will also be requested from Chief Executives to address cultural engagement measures that are not met or need to be progressed further. This will enable a measure of cultural safety to be incorporated within existing reporting mechanisms.
