# **OVERTIME MEAL, TRAVELLING AND OTHER ALLOWANCES**

## **PURPOSE**

This Information Bulletin advises of the release of NSW Treasury Circular 2019-13 Review of Meal, Travelling and Other Allowances, which increases the amount payable for overtime meal allowances in line with the Australian Taxation Office Determination 2019/11 which sets out reasonable allowance amounts for the 2019-20 financial year.

### **KEY INFORMATION**

In line with the adjustment, the overtime meal allowance payable under the following Awards is increased to \$31.25:

- Public Hospital Medical Officers Award
- Public Hospital Career Medical Officers (State) Award
- Hospital Scientists (State) Award
- Public Hospitals (Professional and Associated Staff) Conditions of Employment (State) Award
- Health Employees' Conditions of Employment (State) Award
- Public Health System Nurses' and Midwives (State) Award
- Operational Ambulance Officers (State) Award

The new rate is effective from 1 July 2019. The amount payable under the various payroll codes used for overtime meal allowances should therefore be adjusted as follows:
