CHANGED REPORTING REQUIREMENTS FROM INDIVIDUAL SERVICE PROVIDER DISCIPLINE / SPECIALTY

PURPOSE

The purpose of this Information Bulletin is to inform NSW Health service providers and source system administrators of the changed reporting requirements for the Enterprise Data Warehouse for analysis, reporting and decision support (EDWARD) Individual Service Provider Data Stream from 1 July 2020.

KEY INFORMATION

From 1 July 2020 there are changes to the Individual Service Provider Discipline Specialty classification standard to accommodate reporting requirements pertaining to data set extensions of the Non-admitted Patient and Supplementary Services Data Collection.

The following two categories are new and pertain to staff working within specialist teams who provide care to patients who have experienced violence, abuse or neglect:

- 254499-5 Registered Nurse (Sexual Assault Nurse Examiner)
- 272199-B Sexual Assault Worker

The following Allied Health Profession sub-categories must be expired and from this point forward reported as code 252511. This change may be applied retrospectively.

- 252511-1 Aquatic Physiotherapist
- 252511-2 Cardiothoracic Physiotherapist
- 252511-3 Continence & Women's Health Physiotherapist
- 252511-4 Gerontological Physiotherapist
- 252511-6 Musculoskeletal Physiotherapist
- 252511-7 Neurological Physiotherapist
- 252511-8 Occupational Health Physiotherapist
- 252511-9 Paediatric Physiotherapist
- 252511-10 Sports Physiotherapist

The category description for 252511 must be changed from "Physiotherapist, not further defined" to "Physiotherapist".

The classification change applies to individual service providers from 1 July 2020. Local Health Districts and Specialist Health Networks should aim to implement the changes as soon as practical, using a best endeavours approach, and no later than 30 September 2020.

Individual Service Provider Discipline / Speciality is an existing data element reported via the following EDWARD data streams:

- Individual Service Provider
- Admitted Patient
- Emergency Department
- Non-admitted Patient and Supplementary Services
- Scheduling / Waiting List

The change requires modification to source system configuration. The changes require the following change tasks:

- Add some new categories and EDW code set aliasing to the existing code set.
- Expire some existing categories and modify EDW code set alias.
- Communication of changes to the source system's business users.

It is an LHD/SHN responsibility to instruct their source system support team to implement the changes outlined in this information bulletin. Support providers include, but are not limited to, eHealth NSW application support teams.

EDWARD extract source system build guides published on the <u>ASK</u> provide instructions for source system administrators the code set aliasing requirements for EDWARD extracts.
