EMERGENCY DEPARTMENT (ED) ACCESSIBLE WARDS IN THE PATIENT FLOW PORTAL (PFP)

PURPOSE

This Information Bulletin provides information to all NSW Health staff using the Patient Flow Portal (PFP) concerning the types of inpatient wards that are considered to be "Emergency Department (ED) Accessible", and to facilitate consistency of reporting across the Patient Flow Portal.

KEY INFORMATION

Patient Flow Portal / Emergency Access View Dashboard is NSW Health's enterprise patient flow and care coordination system used for daily operational bed management in

a ward and hospital.

ED Accessible Wards are key to operational bed management and can be defined as acute patient wards that are generally used for daily hospital admissions transiting from the ED.

ED Accessible Occupancy data is also summarised at a Local Health District (districts) / Speciality Health Networks (networks) and state level resulting in a need for consistent ward setup across all NSW Health public hospitals with some exclusions. (e.g. Paediatric wards in a Paediatric Hospital or Specialty Intensive Care wards).

It is required that the flagging of ED Accessible Wards (identified via the term "ED accessible beds" within the PFP) is mandated for all NSW Health hospitals so that reporting consistency is maintained.

For the purpose of this Information Bulletin, a NSW Health Hospital includes Public Hospitals, Multi-Purpose Services, Third Schedule Hospitals and Hospitals under public-private partnerships (such as Northern Beaches Hospital). It does not include Public Psychiatric Hospitals.

It is important to note that daily hospital admissions can be allocated to non-ED accessible wards by the hospital Patient Flow Portal team in line with local policies.
