NEW ADMITTED PATIENT MASTER FINANCIAL CLASSIFICATIONS FOR NON-HOSPITAL RELATED ACCOMMODATION

PURPOSE

To inform NSW Health service providers and source system administrators of changes to the Admitted Patient Data Collection State-Wide Master Financial Class code set.

This document is to be read by Patient Administration System (PAS) administrators, performance units, revenue managers and any administrative staff involved in the development and implementation of inpatient financial classes at a local health district and speciality health network level.

KEY INFORMATION

To comply with the State Health Emergency Operations Centre's (SHEOC) requirement that all patients/clients in Special/Supported Health Accommodation/Community Supported Accommodation (SHA/CSA) are to be admitted.

Financial accounting, policy, insurance and revenue branch in consultation with key stakeholders has determined that two new financial classes are to be deployed. These financial classes will be added to the State-Wide Master Financial Class code set.

THE TWO NEW FINANCIAL CLASSES ARE:

		Persons entering Australia via an international pathway (e.g. airport/seaport) who must isolate in a quarantine facility and pay a quarantine fee. E.g. International passengers, seafarers or airline crew.	
NA	No Charge Accomm-NHR	No Charge Accommodation – Not Hospital Related	
		Persons deemed by NSW Public Health Unit who are:	
		Community Covid Positive	
		Close and/or casual contacts	
		 Parent(s)/Guardian/Carer of unaccompanied minors or support person 	
		 Interstate travellers who fall outside the RNSW billing period 	
		 NSW patients transferred from local and outside health district into quarantine facility

Current repurposing of existing financial classes must cease.

These financial classes are to be used to record patients/clients accommodated as close contacts/infectious patients of COVID-19 who cannot self-isolate at home.

The Chart of Accounts to use are available on the Revenue SharePoint.

The fee charged for the 'CA' financial class is cost recovery. The effective from date for both financial classes is 1 October 2021.

These financial classes will be utilised as/when needed. Once quarantining is no longer required, these financial classes will remain for future use.

The financial classification changes apply to all admitted patient data streams, including HIE and EDWARD, and require modification to source system configuration. It is the responsibility of districts and networks to instruct their source system support team to implement the changes outlined in this information bulletin.

The steps are:

- Addition of new codes within source systems and code set aliasing, where necessary
- Cease repurposing existing financial classes (e.g. MNW)
- Communication of changes to the source system's business users.

Source system administrators must ensure that no localised changes are made within the source system to the admitted patient financial class code set.

To request a new financial class code, or to make any changes to a financial class code or descriptive label, districts / networks must complete an *Inpatient Financial Classifications Request Form* which can be found in (IB2021_058).

All requests must be signed off by the District/Network director of finance prior to submission to the Financial Accounting, Policy, Insurance and Revenue branch, NSW Ministry of Health.
