

Staff Specialist (State) Award Salary Increases

Summary This Information Bulletin advises of increases in rates of pay and allowances from the beginning of the first pay period to commence on or after 1 July 2023 for staff specialists employed under the Staff Specialists (State) Award. Staff specialists also receive the increase of 0.5% to the Superannuation Guarantee Levy to 11% from 1 July 2023.

Staff Specialists (State) Award Salary Increases

PURPOSE

This Information Bulletin is to advise staff of a one year increase of 4.00% per cent to remuneration rates commencing from the first full pay period on or after 1 July 2023 for staff specialists covered by the Staff Specialists (State) Award.

Staff specialists also receive the increase of 0.5% to the Superannuation Guarantee Levy, to 11% from 1 July 2023.
